Subject: Guidelines for Obtaining No Objection Certificate (NOC) for Appearing in Entrance Examinations for Pursuing Higher Studies.

In pursuance of the Office Memorandum issued by the Health & Family Welfare Department, Government of Mizoram vide No.A-52011/1/2026-HFW dated 5.6.2026 regarding the procedure and guidelines for obtaining a No Objection Certificate (NOC) to appear in entrance examinations for pursuing higher studies, the same is hereby circulated for information and strict compliance by all concerned.

All officers and employees under Zoram Medical College & Hospital who intend to appear in any entrance examination for admission to higher studies are advised to familiarize themselves with the provisions contained in the enclosed Office Memorandum and ensure that the prescribed procedure is followed before submitting applications for issuance of NOC.

It is further informed that applications for NOC shall be processed only in accordance with the guidelines and conditions stipulated in the said Office Memorandum. Any application submitted without fulfilling the prescribed requirements may not be considered.

All Heads of Departments/Sections are requested to bring the contents of this Circular and the enclosed Office Memorandum to the notice of all officials under their control.

OFFICE MEMORANDUM

Dated Aizawl, the 5th June, 2026

No.A-52011/1/2026-HFW: With a view to avoid deficiency and shortage of doctors to replace the posts vacated by Medical Officers pursuing higher studies and in the interest of public service, the Competent Authority hereby lays down the following guidelines/criteria for obtaining a 'No Objection Certificate (NOC)' to appear in entrance examination for prosecuting higher studies under Health & Family Welfare Department with immediate effect and until further orders:

1. Serving doctors intending to pursue higher studies or appear in Entrance Examination for higher studies are required to seek NOC from the Competent Authority i.e. the Government of Mizoram in Health & Family Welfare Department through proper channel.
2. The government may grant NOC for pursuing higher studies to doctors who have satisfactorily completed period of probation and has rendered not less than 5 (five) years' continuous service under the State Government.
3. Any person who appears for Entrance Examination without prior approval of the Government shall not be given NOC at a belated stage.
4. Persons seeking NOC for higher studies should submit application in the prescribed format (attached) duly filled in. **The application should be submitted well in advance.**
5. In the event of their being selected to pursue higher studies, study leave shall be entertained in respect of those candidates/employees who rendered a regular service of 5 years (counting from the date of appointment on regular basis into government service to the date of submission of application for NOC) only.

This supersedes the Office Memorandum issued vide No.A.24011/6/2022-HFW dated 28.10.2022.

Any need for relaxation (genuine, valid and fulfilling the interest of the State and the Public) shall be considered, on case to case basis.
