CIRCULAR

Pursuant to the directive issued by the Medical Assessment and Rating Board (MARB), National Medical Commission (NMC), vide Letter No. **N-19011/13/2024-AssessmentCell/MARB** dated **21st July 2026**, all faculty members are hereby informed that statutory assessments for the academic year **2026-27** will commence shortly for establishment of new PG courses/colleges and enhancement of PG seat capacity.

The NMC has observed that, during previous assessment cycles, some faculty members selected from the National Faculty Database with valid AEBAS IDs were either not relieved by their parent institutions in time or withdrew from assigned duties at the last moment. Such actions disrupt the assessment process and affect the statutory timelines prescribed by the Commission.

Accordingly, the following instructions shall be strictly complied with:

1. **Mandatory Participation:** Faculty members selected for NMC assessment duties shall honour their assignments and report as scheduled. Withdrawal shall be permitted only under exceptional and unavoidable circumstances.
2. **Official Duty:** All NMC assessment assignments shall be treated as **Official Duty (OD)**. Selected faculty members will be relieved as required to enable timely reporting.
3. **Avoid Last-Minute Withdrawal:** Cancellation or withdrawal from assigned duties without valid reasons will be viewed seriously, as it hampers the smooth conduct of the assessment process.
4. **Dissemination:** Heads of Departments shall ensure that this circular is communicated to all faculty members under their control.

All faculty members are requested to extend their full cooperation in ensuring the successful conduct of NMC statutory assessments. Non-compliance with these instructions will be dealt with as per the directions of the competent authority.
