6. Shortlisting of candidates for Stage-III:

- A merit list will be prepared based on marks obtained in from Stage I (Qualification, experience & statement of purpose carrying 40 marks), and written test (Stage –II). To qualify for an interview (Stage-III), a candidate must obtain at least 20 marks in Stage-I and at least 25 marks in the written test (Stage-II). The candidates will be invited for the interview strictly in order of merit based on the marks obtained by the candidates in stage I & II.
- The interview conducted by the respective department will have a weightage of 10 marks.

Final Result:

Results will be declared based on total marks obtained in Stage-I, Stage-II, and Stage-III.

7. JOINING

Selected candidates are required to join on 01.10.2024 or before 30.09.2024. In case the candidate fails to join by this date and no written request for extension is received by 30.09.2024, it will be assumed that he/she does not intend to join the course and the seat will be offered to the next candidate on the waiting list.
