## TERMS AND CONDITIONS

- 1. The State Referral Hospital Pharmacy Canteen (Store) will be available for lease for a period of 2 (two) years to Pharmacists holding valid drug licenses or any valid drug license holder who employs a full-time qualified Pharmacist, as agreed upon in a duly signed deed of agreement between both parties.
- 2. The procurement of the Hospital Canteen shall be conducted through a competitive tendering system. Adequate advertising and a sufficient submission period shall be ensured.
- 3. Applicants must attach the required documents to their applications for scrutiny by the Pharmacy Board.
- 4. Tenders should be submitted in sealed envelopes.
- 5. On the tender opening day, representatives of the tenderer or a firm should be present with the original copy of their General Drug License.
- 6. The minimum bidding amount for the Canteen shall be Rs. 50,000/- (Rupees Fifty Thousand only) per month.
- 7. A security deposit of Rs. 1,00,000/- (Rupees One Lakh only) must be submitted in the form of Demand Draft in favour of the Medical Superintendent, State Referral Hospital at the time of submitting the tender. This deposit will be refunded without interest to unsuccessful bidders.
- 8. The Pharmacy Store/Canteen must be opened and available to servce the hospital 24 hours a day, 7 days a week.
- 9. The new occupant must purchase any remaining medicines, medical appliances and minor consumables, surgical materials stocked by the previous occupant within the premises of the pharmacy. The Pharmacy Board is not responsible for this.
- 10. The outgoing occupant must not procure additional materials to benefit from the stock turnover. The handover should occur within one month of the agreement signing between the Board and the newly selected bidder.
- 11. The Pharmacy Canteen must adhere to all Government Programs such as BPL, AB-PMJAY and Cashless, etc.
- 12. The Pharmacy Canteen must maintain a ready-make stock of emergency and essential drugs as prescribed by the Hospital/Government of Mizoram from time to time.
